5. Agencies having minimum of 5 years experience

INSTRUCTION TO THE TENDERERS

1. Quotation must be submitted giving complete details in the enclosed tender papers
2. The rates quoted should remain valid for complete contract period and during extended period.
3. Care must be taken so that no furniture, fixture, fittings are damaged while carrying out the work by the contractor. Any damage done to the same will

have to be repaired / replaced by the contractor and on termination of the contract the contractor will handover all the supplied equipment / articles in good condition. .

4. Prices quoted for services should be inclusive of all statutory levies and duties for free delivery / service . The bill raised after tendering the services shall be subject to the tax deduction at source.
5. The contractors should adhere to the statutory regulations viz., Minimum wages Act, Shop and Commercial Establishment Act, ESI scheme and any other regulation covering labour contract.
6. After acceptance of the contract if any / all the terms and conditions of the contract is / are violated, then the hirer reserves the right to terminate the contract. In such cases, **the security deposit amount will be forfeited.**
